Q4

West Virginia is facing many challenges. What do you consider to be the most important and critical challenge that threatens our state and what is your plan to alleviate this threat?

I believe the main issue for West Virginia at this point is the "great escape" that thousands of young people do after graduating high school and college. Our most talented young people leave for better opportunity, putting strains on our already limited work force. This in turn puts a strain on businesses looking to hire West Virginians, and in turns forces businesses and industry to look elsewhere for talent or a more friendly business environment. West Virginia needs to focus on lowering income tax and creating the incentives to keep and retain young people as well attract new residents looking to work and create new businesses.

During the 2020 Legislative Session, SJR 9 and SB 837 moved in the West Virginia Senate, but fell short of the votes needed to move to the House of Delegates. The intent of the effort was to allow West Virginians to vote on a constitutional amendment to phase-out/repeal of manufacturing inventory, machinery, and equipment tax, business inventory, and tax on passenger vehicles while making local governments and schools whole. Please describe your ideas for addressing this issue which requires a change to the West Virginia Constitution.

The failure of these bills rests solely on the leadership of the House of Delegates. As a Libertarian, I believe that the constitutional amendment to accomplish these items is a must-have for West Virginia to move forward, especially in these times of uncertainty.

Q6

What ideas do you have to help build our state's economy and improve West Virginia's position in competing for investment and job growth?

The state also needs to focus on property development in the way of incentives for developing flat property suitable for commercial and industrial properties. Developers find it difficult with West Virginia's terrain, we need to help them by creating incentives and removing burdensome regulations and permitting and allow them to develop the property needed for new businesses.

Use of and addiction to opioids in West Virginia and our region have reached crisis levels. This is a problem being recognized not only at the state level, but at the federal level. What ideas do you have to help stop this devastating trend in our state?

Racial justice and equity, LGBTQ rights and gender equity are important factors for many current West Virginia employers, companies that consider moving to our State, and employees who may consider relocating to West Virginia. How would you address these issues to recruit and retain companies and employees for whom this is a priority?

West Virginia has always been an At-Will employment state. As a Libertarian, that's enough for me. The relationship between Employer and Employee is their relationship and not the role of government to decide. No one should be fired or denied employment for their race, equity, or their sexual orientation but I don't think specific laws or regulations will prevent that from happening. The best thing the state can do is allow businesses to do business how they see fit.

Q9

What are your specific ideas related to developing a diverse and skilled workforce in West Virginia?

You have to start by retaining and attracting young people. To do that you must make the market as free as possible. It's a snowball that starts with eliminating taxes and burdensome regulations. That in turns attracts new business and industry and that in turns attracts new workers and young people. As the snowball grows, it attracts new service and entertainment industry jobs. Remove the barriers for business and the economy will grow creating the diverse and skilled workforce we need naturally.

The West Virginia Department of Environmental Protection proposed a rule for the 2021 Legislative Session to adopt a portion of US EPA recommended human health criteria which established limits for certain environmental permits. The WVMA is actively involved in ongoing discussions related to these criteria and supports the WV DEPs approach to establish an active work group to further evaluate these important measures. Please describe your position on the proposed rule.

Business and Industry should have their opinions heard over any type of new permitting that may effect their businesses. I would have to look at the EPA human health criteria very closely, but I can't imagine it does much more to protect the environment as it does hurt future expansion of business and industry.

Please describe policies that you believe may be helpful in balancing state regulations and environmental rules while maintaining a competitive atmosphere for industrial job growth and investment?
