Q1

Describe your overall philosophy toward the role of state government as it relates to business and industry.

Q4

West Virginia is facing many challenges. What do you consider to be the most important and critical challenge that threatens our state and what is your plan to alleviate this threat?

The most important and critical challenge is a skilled, drug free workforce. West Virginia faces so many issues, especially the drug crisis, but it is expanded greatly when it comes to a ready and skilled workforce. We need to invest in our children through skilled trades and more career and technical resources at an earlier age. We also need to focus on rehabilitation of able bodied adults through workforce readiness. My plan would be to shift portions of current financial assistance to higher education institutions to more CTE programs for middle and high school students and to invest in technical workforce rehabilitation programs for adults.

During the 2020 Legislative Session, SJR 9 and SB 837 moved in the West Virginia Senate, but fell short of the votes needed to move to the House of Delegates. The intent of the effort was to allow West Virginians to vote on a constitutional amendment to phase-out/repeal of manufacturing inventory, machinery, and equipment tax, business inventory, and tax on passenger vehicles while making local governments and schools whole. Please describe your ideas for addressing this issue which requires a change to the West Virginia Constitution.

I believe anytime we can give the people of West Virginia a voice through an election, we need to do that. SJR 9 and SB 837 should have been approved and entrusted to the people of West Virginia and unfortunately that was taken away from them. I would be in favor of voting for these measures to let West Virginians decide the constitutional amendment.

What ideas do you have to help build our state's economy and improve West Virginia's position in competing for investment and job growth?

As stated before, we need to invest in a ready, skilled and drug free workforce. When in competition for investment and job growth, this is a major factor with potential business and industry. We also have a long history of over regulation which turns potential investors away. West Virginia needs to invest in a comprehensive study that focuses on de-regulation so the Legislature can work on removing barriers to potential job growth. These are all heavy lifts as we have seen in recent legislative sessions, but they are all extremely important to improve the economy in West Virginia.

Use of and addiction to opioids in West Virginia and our region have reached crisis levels. This is a problem being recognized not only at the state level, but at the federal level. What ideas do you have to help stop this devastating trend in our state?

I do not believe that one person has the ideas to stop the opioid crisis in West Virginia. This has been looked at through many different avenues at the state and federal level. I am focused on winning my election so that I may be part of the 2021 legislative session, but as of now, I am not and therefore have not focused my efforts on rules proposed for 2021.
