The intent of the effort was to allow West Virginians to vote on a constitutional amendment to phase-out/repeal of manufacturing inventory, machinery, and equipment tax, business inventory, and tax on passenger vehicles while making local governments and schools whole. I favor phasing out the tax. Requires full commitment of Gov & legislative leadership to develop a plan that prioritizes most critical areas to repeal and creates new sources to support replacing the funding this tax currently provides.
