Q4

West Virginia is facing many challenges. What do you consider to be the most important and critical challenge that threatens our state and what is your plan to alleviate this threat?

Many challenges. I would like to see the 5% vehicle tax done away with as it pertains to new residents or businesses. The virus is the main challenge in relation to businesses and the school system. I feel a closer relationship between the teachers and state govt., may be needed for the safety of all.

Q5

During the 2020 Legislative Session, SJR 9 and SB 837 moved in the West Virginia Senate, but fell short of the votes needed to move to the House of Delegates. The intent of the effort was to allow West Virginians to vote on a constitutional amendment to phase-out/repeal of manufacturing inventory, machinery, and equipment tax, business inventory, and tax on passenger vehicles while making local governments and schools whole. Please describe your ideas for addressing this issue which requires a change to the West Virginia Constitution.

I think this is needed and should have been passed to allow the voters of WV to decide this matter. These taxes are wrong and are a burden on businesses.

Q6

What ideas do you have to help build our state's economy and improve West Virginia's position in competing for investment and job growth?

Restructure the business tax to make it less demanding on the businesses. The state really needs to focus on tourism with the understanding of allowing businesses to come onto state property with extremely long and inexpensive leases to meet the needs of the area. For ex: Allow a company to build a hotel and civic center on Beech Fork Lake with a water park and allow the Virginia Port Authority to take over the intermodal facility in Pritchard. For now both are failing. Business run instead of state controlled.

Q7

Use of and addiction to opioids in West Virginia and our region have reached crisis levels. This is a problem being recognized not only at the state level, but at the federal level. What ideas do you have to help stop this devastating trend in our state?

Expand WV Hope and Jobs Act to include faith based facilities. Hold accountable state agencies and other agencies that accept state and federal help as to their success rate. The idea to keep an addict medicated for the rest of the addict's life is wrong. Give the addict a choice: a year in rehab with vocational training, and if you graduate after a year, expungement of your arrest record. Otherwise, go to jail.

Racial justice and equity, LGBTQ rights and gender equity are important factors for many current West Virginia employers, companies that consider moving to our State, and employees who may consider relocating to West Virginia. How would you address these issues to recruit and retain companies and employees for whom this is a priority?

I think the recent supreme court ruling takes care of this situation; however, I truly think it should be left up to the company, as to who they want to employ.

Better training in schools may help with this. This is where a good vocational school can be of great importance.
