#### Q4

West Virginia is facing many challenges. What do you consider to be the most important and critical challenge that threatens our state and what is your plan to alleviate this threat?

Our economic downturn due to COVID-19 is our most critical challenge at this juncture. We must continue to work hard to stay safe, but we also cannot continue to choke our manufacturing industry and threaten their survival. After COVID, we must diligently work to listen to manufacturing's concerns and do all we can to lessen governmental burdens on their success.

### Q5

During the 2020 Legislative Session, SJR 9 and SB 837 moved in the West Virginia Senate, but fell short of the votes needed to move to the House of Delegates. The intent of the effort was to allow West Virginians to vote on a constitutional amendment to phase-out/repeal of manufacturing inventory, machinery, and equipment tax, business inventory, and tax on passenger vehicles while making local governments and schools whole. Please describe your ideas for addressing this issue which requires a change to the West Virginia Constitution.

I believe business and inventory tax would be important to remove. It must be done, however, in a common sense manner that doesn't ruin individual county budgets, forcing them to levy higher property taxes in turn. The B&I tax can be done away with eventually in a phased approach.

#### Q6

What ideas do you have to help build our state's economy and improve West Virginia's position in competing for investment and job growth?

I strongly believe in building a better workforce through educational development (trade school opportunities), tax structure reform, and infrastructure building. Broadband services and improved roads are critical to this vision.

## Q7

Use of and addiction to opioids in West Virginia and our region have reached crisis levels. This is a problem being recognized not only at the state level, but at the federal level. What ideas do you have to help stop this devastating trend in our state?

We must stop slapping the drug traffickers on the wrist. We also must ensure all who need rehabilitation, receive it. Early childhood training in schools to break the cycle of addiction is also extremely important. Solving this crisis is a direct link toward saving businesses across this state and changing the narrative and stigma that surrounds us.

### Q8

Racial justice and equity, LGBTQ rights and gender equity are important factors for many current West Virginia employers, companies that consider moving to our State, and employees who may consider relocating to West Virginia. How would you address these issues to recruit and retain companies and employees for whom this is a priority?

All must be treated equal under the law in the state of WV, and the legislature must ensure this continues to be the case.

### Q9

What are your specific ideas related to developing a diverse and skilled workforce in West Virginia?

Trade school development is essential. We have to match our young people's skill sets to what our manufacturing firms, already here and incoming, truly need. With displaced workers due to shifting market trends and technology needs have shifted how value is perceived among companies. Reinforcement and incentive for post-secondary education would help create a workforce conducive to manufacturing business success.

#### Q10

The West Virginia Department of Environmental Protection proposed a rule for the 2021 Legislative Session to adopt a portion of US EPA recommended human health criteria which established limits for certain environmental permits. The WVMA is actively involved in ongoing discussions related to these criteria and supports the WV DEPs approach to establish an active work group to further evaluate these important measures. Please describe your position on the proposed rule.

I agree with WVMA in that the work group is a careful approach toward establishing these limits. The WVMA must be allowed to continue to have a prime seat at the table to provide needed insight on how these limits might affect industry as a whole, hopefully allowing for compromise and understanding.

#### Q11

Please describe policies that you believe may be helpful in balancing state regulations and environmental rules while maintaining a competitive atmosphere for industrial job growth and investment?

It is a duty to conserve the earth and its resources. In saying that, a principled measure in ensuring a balance would be to make sure the benefits are more powerful than the costs. If the harm to a business is far greater than the benefits of an environmental regulation, then that regulation should be, on principle, repealed.
