4. West Virginia is facing many challenges. What do you consider to be the most important and critical challenge that threatens our state and what is your plan to alleviate this threat?
Dur biggest challenge is staying competitive with other states. To that end, we need to amend our constitution so that we can remove the tax on property, machinery an inventory that hampers manufacturers and other businesses
5. During the 2020 Legislative Session, SJR 9 and SB 837 moved in the West Virginia Senate, but fell short of the votes needed to move to the House of Delegates. The intent of the effort was to allow West Virginians to vote on a constitutional amendment to phase-out/repeal of manufacturing inventory, machinery, and equipment tax, business inventory, and tax on passenger vehicles while making local governments and schools whole. Please describe your ideas for addressing this issue which requires a change to the West Virginia Constitution.
As aforementioned, we need to continue to educate legislators and the public on how important this change would be for economic development and how it improves living standards for all West Virginians.
6. What ideas do you have to help build our state's economy and improve West Virginia's position in competing for investment and job growth?
Consistent with my previous responses, we need to eliminate job-killing taxes and unnecessary regulations.
7. Use of and addiction to opioids in West Virginia and our region have reached crisis levels. This is a problem being recognized not only at the state level, but at the federal level. What ideas do you have to be be at the federal level.

I have already supported legislation that has been made into law that strengthens oversight of opioid prescriptions, increases access to alternative treatments and establishes additional substance
treatments and establishes additional substance abuse treatment programs.

I have sponsored several bills that provide for alternative educational pathways, including vocational training, community and techical colleges and programs that permit middle schoolers to start training.

The West Virginia Department of Environmental Protection proposed a rule for the 2021 Legislative Session to adopt a portion of US EPA recommended human health criteria which established limits for certain environmental permits. The WVMA is actively involved in ongoing discussions related to these criteria and supports the WV DEPs approach to establish an active work group to further evaluate these important measures. Please describe your position on the proposed rule. I was involved in the process of craffing and enacting that rule.
11. Please describe policies that you believe may be helpful in balancing state regulations and environmental rules while maintaining a competitive atmosphere for industrial job growth and investment? A good policy would be to require an economic impact study for any and all legislation.
12. What would you like to share with our members that we have not asked? The Trump administration is working to bring back manufacturing jobs to the U.S. I support these efforts and WV will benefit from this especially if we eliminate the business inventory and machinery tax.
